



MEMORANDUM OF UNDERSTANDING

Between

NIROGYA LIFE LINE FOUNDATION (NLLF), CHANDIGARH

AND

NATIONAL INSTITUTE OF TECHNICAL TEACHERS TRAINING AND RESEARCH, CHANDIGARH

AND

NATIONAL INSTITUTE OF TECHNICAL TEACHERS TRAINING AND RESEARCH, CHANDIGARH (hereafter referred to as NITTTR, Chandigarh), an Institute registered under the Societies Registration Act, 1860 and is managed by a Board of Governors.

BACKGROUND

The mission of Nirogya Life Line Foundation is a healthier tomorrow for the populace by delivering affordable, world-class health care that can be equitably accessed. NLLF, Chandigarh is promoting the Futuristic Healthcare Delivery Ecosystem based on the patented technologies incubated by ICMR- Centre for Innovation & BioDesign, PGIMER, Chandigarh. The ultimate aim is to improve the quality of life accompanied with augmentation of quality healthcare, ensuring availability of quality healthcare practitioners and partnering with local government agencies in matters related to healthcare.

WHEREAS NITTTR, Chandigarh, (currently a Deemed to be university under distinct category) was established in the year 1967 by the Ministry of Education, Government of India with several objectives viz. training teachers of polytechnics (and Engineering Colleges, as added later on) through different types of courses, fostering and promoting research in improving classroom and laboratory instruction, preparing and supplying teaching aids and instructional materials, associating with other academic bodies of technical education to achieve quality improvement in academic programs, collaborating with institutions and organizations in India and abroad having similar objectives and functions, and interacting with industries in formulating training programs of mutual interest. departments covering Engineering, Science, Curriculum, Education, Rural Development and Management programs. The institute offers ME and Ph.D. programs in line with NEP 2020.

OBJECTIVES

Both NLLF, Chandigarh and NITTTR, Chandigarh are now ready to synergize their efforts by pooling their expertise and resources to form a nucleus for promoting Futuristic Healthcare Delivery Ecosystem by channelizing the unique expertise, intellectual and infrastructural capabilities of both parties.

FINANCIAL TERMS

There is no direct financial obligation on either institution unless specifically agreed to. The financial requirements of individual institutions for joint project proposals will be separately mentioned in joint projects while submitting to funding agencies. Before the start of any activity, financial terms will be decided pertaining to that particular activity in advance.

DURATION

This agreement shall come into effect on the day of the approval by both parties and continue to be valid and in force for a period of three years.

TERMINATION

Either institution may terminate this agreement provided that a written notice of this intent is given to the other at least 01 month prior to the termination.

PUBLICATIONS

Publications that may come about in the course of execution of collaborative projects between NLLF, Chandigarh and NITTTR, Chandigarh will be the joint property unless otherwise mentioned clearly in project proposals or project-specific agreements.

CONFIDENTIALITY

During the Term of MOU, either party may provide to the other proprietary and confidential information that it considers essential for the conduct of any PROJECT for their sole discretion. NITTTR, Chandigarh and NLLF, Chandigarh agree to hold PROPRIETARY INFORMATION in confidence and to protect it against disclosure to the public and third parties. Accordingly, both NITTTR, Chandigarh and NLLF, Chandigarh shall employ protective measures fully commensurate with those used by them to protect their own trade secrets and other confidential information from disclosure to the public and third parties, but in no event less than ordinary degree of care required by law to preserve the secrecy of information that under such law in deemed confidential. By way of example, such efforts will include the act of obtaining the execution of suitable confidentiality agreements from other parties and from other persons to whom such information is disclosed in the course of execution of the PROJECT and to retrieve the connected documents on completion of the project where given for the same.

Any difference of opinion arising on any matters under the preview of the MoU will be referred to Director, NLLF, Chandigarh and Director, NLTTTR, Chandigarh for resolution through mutual consent.
